Natus Medical Incorporated hereby authorizes and requests the Commissioner of Patents and Trademarks and the Canadian Intellectual Property Office to issue said trademark registrations to said Natus Neurology Incorporated, the assignee of the entire right, title and interest in and to the same, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which trademark registrations may be granted as fully and entirely as the same would have been held by me had this assignment and sale not been made.

The undersigned hereby grants the firm of Temmerman Law Office (One Market Street, Spear Tower, 36<sup>th</sup> Floor, San Francisco, California




