Corrective Assignment Supporting Affidavit
Trademark Application Serial Number 85/642,307

The previously recorded document (Reel/Frame: 5026/0193) assigning the rights in application serial number 85/642,307 from Eugene F. Branon to Big Barn Grazers CPG, LLC was erroneous and should not be considered against the property.

Another attorney, who was apparently not familiar with the fact pattern, prepared and recorded the document without the review or approval of Applicant's attorney. The form of the assignment filed was for a mark in use, and was not suitable for an assignment of an intent to use mark.

The trademark VERMONT TAPPED is not yet in use and an amendment to allege use under Section 1(c) or 1(d) of the Trademark Act has not been filed. In addition, there is some question as to whether Mr. Branon has an ongoing and existing business to which the mark pertained.

Furthermore, Mr. Branon owns a second mark, FROM THE ROOTS OF VERMONT, serial number 85/642,286 which was not assigned to Big Barn Grazers CPG, LLC with VERMONT TAPPED. If Mr. Branon had an ongoing and existing business, and the entire business or portion thereof was transferred to Big Barn Grazers, both marks should have been assigned.

In view of the above, the previously recorded document is defective and Eugene F. Branon has been and continues to be the owner of the application serial number 85/642,307.
