Assignor and Assignee each hereby acknowledges and agrees that neither the representations and warranties nor the rights, remedies or obligations of any party under the Agreement shall be deemed to be enlarged, modified or altered in any way by this instrument. To the extent that any term or provision herein is inconsistent with the Agreement, the terms and provisions of the Agreement shall control.




