WHEREAS, Ciba Corporation, formally Ciba Specialty Chemicals Corporation, initially entered into a Local Asset Sale and Transfer Agreement on June 30, 2006 with Huntsman International LLC, now known as Huntsman Advanced Materials GmbH, wherein, multiple trademarks were Assigned over to Huntsman including LANACRON, and

WHEREAS, the registration number of LANACRON was listed incorrectly in said agreement and therefore the mark was never transferred, and.

WHEREAS Huntsman Advanced Materials (Switzerland) GmbH, a corporation, duly organized under the laws of Switzerland having its principal offices at Klybeckstrasse 200, CH-4057 Basel, Switzerland (hereinafter referred to as "Assignee") desires to acquire the entire right, title, and interest in and to the Trademark in accordance with the terms of the Local Asset Sale and Transfer Agreement,

NOW, THEREFORE, in consideration of good and valuable consideration, receipt of which is hereby acknowledged by Assignor, Assignor does hereby, assign, transfer and set over to Assignee, its successors and assigns, its entire right, title and interest in and to the Trademark together with the goodwill of the business symbolized by the Trademark and any and all rights relating to the same, including all rights, interests, claims and demands, recoverable in law and in equity, that Seller has or may have in profits and damages for past and future infringements of the Trademark.
