## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT ("Assignment") is made as of the 7th day of May, 2013, between TWINS BALLPARK LLC, a Minnesota limited liability company with offices at 1 Twins Way, Minneapolis, MN 55403 ("Assignor"), on the one hand, and MINNESOTA TWINS, LLC, a Delaware limited liability company with offices at Target Field, 1 Twins Way, Minneapolis, MN 55403 ("Assignee"), on the other hand.

WHEREAS, Assignor is the owner of United States Registration No. 3,936,635 for TWINS DUGOUT DOG in International Class 29 for "Hot dogs";

WHEREAS, Assignor is the owner of United States Registration No. 4,127,293 for ORIGINAL TWINS DOG in International Class 30 for "hot dog sandwiches";

WHEREAS, Assignor is the owner of United States Application Serial No. 77/951,853 for TWINS BIG DOG in International Class 30 for "hot dog sandwiches sold exclusively at the ballpark for the MINNESOTA TWINS professional baseball club" (collectively, Application Serial No. 77/951,853 and Registration Nos. 3,936,635 and 4,127,293 are the "Application and Registrations") (collectively, TWINS DUGOUT DOG, ORIGINAL TWINS DOG and TWINS BIG DOG are the "TWINS DOG Marks");

WHEREAS, Assignor claims to have used the TWINS DOG Marks in commerce since at least as early as April 2, 2010; and

WHEREAS, Assignor desires to transfer all of its rights, title and interest in and to the TWINS DOG Marks together with the goodwill of the business symbolized thereby, and the Application and Registrations, to Assignee, and Assignee desires to accept said transfer.

NOW, THEREFORE, for the sum of \$1.00 and other good and valuable consideration,

the receipt and sufficiency of which is hereby acknowledged, Assignor, as of the date indicated above, assigns and transfers to Assignee, its successors and assigns, absolutely and forever, all of Assignor's rights, title and interest in and to the TWINS DOG Marks, whether statutory or at common law, including the Application and Registrations, together with the goodwill of the business symbolized by the TWINS DOG Marks, and all causes of action for any and all past infringements of the rights so assigned occurring before or after the date of this Assignment and the right to collect and retain the proceeds therefrom, and Assignor agrees to provide Assignee with any documentation, specimens, use evidence, and/or other materials as may be requested from time to time by Assignee to support the recordation of this Assignment and/or prosecution and maintenance of the Application and Registrations for the TWINS DOG Marks with the United States Patent and Trademark Office or otherwise to enforce Assignee's rights in the TWINS DOG Marks.
