CERTIFICATE OF AMENDMENT OF SIXTH AMENDED AND RESTATED ARTICLES OF INCORPORATION OF NEXIANT a California corporation

Vince Sheeran and Scott Poteracki hereby certify that:

1. They are the Chief Executive Officer and Secretary, respectively, of Nexiant, a California corporation (the "Corporation").

2. ARTICLE I of the Sixth Amended and Restated Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

"The name of this corporation is MarginPoint."


3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.

4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of each class entitled to vote with respect to the foregoing amendment was 3,717,373 shares of Common Stock, 1,252,915 shares of Series A Preferred Stock, 6,050,000 shares of Series B Preferred Stock, 11,775,334 shares of Series C Preferred Stock, 11,758,086 shares of Series D Preferred Stock and 62,693,837 shares of Series E Preferred Stock. The number of shares voting in favor of the amendments set forth herein equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%) of the Common Stock (including shares of Preferred Stock voting on an as-converted to Common Stock basis), and more than sixty percent (60%) of the Series B Preferred Stock, Series C Preferred Stock, Series D Preferred Stock and Series E Preferred Stock, voting together as a single series on an as-converted to Common Stock basis.
