TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement is made as of June 5, 2013 by and among Northwire, Inc., a Minnesota corporation (the "**Debtor**"), and Bank of the West, a California banking corporation, for itself and as administrative agent (in such capacity, the "**Administrative Agent**") for the Lender Parties, as defined in the Credit Agreement described below.

Pursuant to a Credit Agreement (together with all amendments, modifications and restatements of such agreement, the "Credit Agreement") of even date herewith among the Debtor, the several banks and other financial institutions from time to time party thereto as lenders and the Administrative Agent, the Lender Parties have agreed to make advances to and issue letters of credit for the account of the Debtor.

As a condition to extending credit under the Credit Agreement, the Lenders required the execution and delivery by the Debtor of a Security Agreement (together with all amendments, modifications and restatements of such Agreement, the "Security Agreement") dated June 5, 2013, pursuant to which the Debtor grants the Administrative Agent a security interest in all of the Debtor's personal property.

Pursuant to the Security Agreement, the Debtor is required to execute and deliver this Agreement to the Administrative Agent.

ACCORDINGLY, in consideration of the mutual covenants contained in the Credit Agreement, the Security Agreement and this Agreement, the parties hereby agree as follows:

1. Definitions.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

2. Grant of Security Interest.

In order to secure the Obligations, the Debtor hereby confirms and acknowledges that it has granted and created (and, to the extent not previously granted under the Security Agreement, does hereby irrevocably grant and create) a security interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "**Trademark Collateral**"):

"Specified Intellectual Property" means the Trademarks, including, without limitation, each of the Trademarks listed on <u>Schedule A</u>, including the owner of each item and the application or registration number of each item.

"Trademarks" means each trademark, service mark, collective membership mark, and registration or application for registration of any trademark, service mark or collective membership mark, included in the Collateral, together with the goodwill associated therewith.

3. Representations and Warranties.

The Debtor represents and warrants that the Debtor owns each of the specified Trademarks, free and clear of any Lien other than Permitted Liens.

4. General Rights and Obligations.

Except as expressly set forth herein, the rights and obligations of the Debtor and the Administrative Agent with respect to the Trademark Collateral shall in all respects be governed by the Credit Agreement and the Security Agreement, the terms of which are incorporated as fully as if set forth at length herein.


