Pursuant to O.C.G.A. § 14-2-1002 and § 14-2-1006 of the Georgia Business Corporation Code, Chexar Networks, Inc., a Georgia corporation, hereby submits the following Articles of Amendment:

The Amended and Restated Articles of Incorporation of the Corporation are hereby amended by deleting Article I in its entirety and substituting therefor the following (the "Amendment"):
