**SECOND AMENDMENT TO INTELLECTUAL PROPERTY SECURITY  
AGREEMENT**

**SECOND AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT**, dated as of June 5, 2013 (this "Amendment"), by DayMen Canada Acquisition ULC, an unlimited liability company organized under the laws of British Columbia (the "Grantor") in favor of GE CANADA FINANCE HOLDING COMPANY, in its capacity as Canadian Agent pursuant to the Credit Agreement (in such capacity, the "Canadian Agent").

WITNESSETH:

WHEREAS, the Grantor, together with 0891145 B.C. Unlimited Liability Company, an unlimited liability company organized under the laws of British Columbia ("0891145"), are parties to a Pledge and Security Agreement, dated as of October 21, 2010 (the "Pledge and Security Agreement") in favor of the Canadian Agent, pursuant to which the Grantor and 0891145 executed and delivered an Intellectual Property Security Agreement dated as of October 21, 2010 (the "Existing Intellectual Property Security Agreement") which was filed with the United States Patent and Trademark Office on November 19, 2010 at Reel 004408, Frame 0400 and at Reel 025408, Frame 0575.

NOW, THEREFORE, in consideration of the premises, the Grantor hereby agrees with the Canadian Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Pledge and Security Agreement and used herein have the meaning given to them in the Pledge and Security Agreement.

SECTION 2. Amendment. Schedule I attached to the Existing Intellectual Property Security Agreement is hereby amended and supplemented by adding thereto the Trademarks and Patents of Grantor listed on Schedule I attached hereto (the "Additional Intellectual Property"), and Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of Grantor, hereby mortgages, pledges and hypothecates to the Canadian Agent for the benefit of the Security Parties, and grants to the Canadian Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Additional Intellectual Property.

SECTION 3. Pledge and Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of the Canadian Agent with respect to the security interest in the Additional Intellectual Property are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Amendment is deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall control unless the Canadian Agent shall otherwise determine.




