RELEASE OF GRANT OF SECURITY INTEREST-- TRADEMARKS

WHEREAS, pursuant to that certain Grant of Security Interest - Trademarks, dated May 8, 2012 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4775, Frame 0707 on May 8, 2012, Plusmo LLC (formerly known as Plusmo, Inc.) WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby relinquishes, releases and discharges its security interest in and to the Collateral. Releasor further agrees to execute and deliver to Releasee any and all further documents or instruments and do any and all further acts which Releasee (or Releasee's agents or designees) reasonably request in order to confirm this release and Releasee's right, title and interest in and to the Collateral.
