GRANT OF SECURITY INTEREST IN TRADEMARKS

GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of May 31, 2013, by PLASTIBEC, INC. ("Grantor"), in favor of CENTURY SERVICES LP ("Lender").

WITNESSETH:

WHEREAS, pursuant to that certain Loan Agreement dated as of the date hereof by and among Grantor and Lender (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Loan Agreement"), Lender has agreed to make loans and advances and to extend other financial accommodations Grantor;

WHEREAS, as security for the Loan, pursuant to the terms of the Security Documents, Grantor granted to Lender a continuing first priority security interest in, lien on, and right of set-off against all trademarks of Grantor, whether now owned or existing or hereafter acquired or arising; and

WHEREAS, pursuant to the Loan Agreement, Grantor is required to execute and deliver to Lender this Grant of Security Interest in Trademarks.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. **DEFINED TERMS.** All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement.

2. **GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL.** Grantor hereby grants to Lender a continuing first priority security interest in, and lien upon, all of Grantor's presently existing or hereafter arising right, title and interest (including, without limitation, as licensor or licensee) in and to trademarks, including, without limitation, the trademarks referred to on Schedule A hereto, the goodwill of the business symbolized thereby and all proceeds and products thereof.

3. **SECURITY DOCUMENTS.** The security interests granted pursuant to this Grant of Security Interest in Trademarks are granted in conjunction with, and not in limitation of, the security interests granted to Lender pursuant to the Security Documents. Grantor hereby acknowledges and affirms that the rights and remedies of Lender with respect to the security interest in the trademarks and related Collateral made and granted hereby are more fully set forth in the Security Documents, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.



<p>Note: When we file for these, the names or logos are limited to interior decorative products or more specifically interior window covering products (i.e. blinds such as verticals and/or horizontal and/or shutters, etc...) any type of window dressing.</p> <p>If we end up with any "examiner objections" when filing for either the logo or the word mark, I suggest we include "by Plastibo" in small text somewhere. In the past we have been able to overcome examiner objections by adding the company name to the logo.</p>							
<p>Note(1): We have signed a document with HYDROGIC saying that we would like for them to keep in good standing Royal (which is used in design) for Plastibo not to have to re-register as we would not be granted Trends any longer as there are two other applicants in line with similar trademarks in window coverings. Scott Bales/legal counsel at GGC has already talked to us so.</p>							
<p>Note(2): Under our lawyers advice, we will not pursue Providence trade-mark as there are other similarities in the mark space. We will however continue to use for our collection.</p>							
<p>Note(3): I have filed for CELLWOOD trade-mark in the USA. If accepted, we will use with Extracolors and Bellagio and Coordinates in the future. CELLWOOD trade mark has been refused by the USA examiner citing ALCOA having wordmark on non-retail products (such as vinyl).</p>
