ARTICLES OF MERGER

**MERGING
LEESON ELECTRIC CORPORATION
(a Wisconsin corporation)
WITH AND INTO
MARATHON ELECTRIC MANUFACTURING CORPORATION
(a Wisconsin corporation)**

ARTICLES OF MERGER executed as of this 29th day of December, 2006, by and between Marathon Electric Manufacturing Corporation, a Wisconsin corporation (hereinafter referred to as "Survivor"), and Leeson Electric Corporation, a Wisconsin corporation (hereinafter referred to as "Merging Corporation"), in accordance with Sections 180.1101 and 180.1105 of the Wisconsin Business Corporation Law ("WBCL").

ARTICLE I

The respective Boards of Directors of Survivor and Merging Corporation, in accordance with their respective Articles of Incorporation and By-laws and Sections 180.1101 and 180.1103 of the WBCL, each adopted resolutions approving a Plan of Merger (the "Plan of Merger"), a true and correct copy of which is attached hereto as Exhibit A and incorporated herein by reference.

ARTICLE II

The respective sole shareholder of Survivor and Merging Corporation, in accordance with Section 180.1103 of the WBCL, adopted resolutions approving the Plan of Merger.

ARTICLE III

The Merging Corporation does not have a fee simple ownership interest in any Wisconsin real estate.

ARTICLE IV

The executed Plan of Merger is on file at the principal place of business of the surviving corporation.

ARTICLE V

The surviving corporation will provide a copy of the Plan of Merger, upon request and without cost, to any shareholder of a corporation that was a party to the merger or, upon payment to the surviving corporation of an amount equal to the cost of producing the copy, to any other interested person.

ARTICLE VI



ARTICLE VII


