1. Mike Jensen and Naimish Patel do hereby certify that they are the President and Secretary, respectively, of Cumming Construction Management, Inc., a corporation duly organized and existing under the laws of the State of California.
2. Cumming Construction Management, Inc. ("*Parent*") owns 100% of the issued and outstanding shares of the common stock, par value \$1.00 per share, of Southern Management Group, Inc., a South Carolina corporation ("*Subsidiary*"), which has no class of stock outstanding other than such common stock.
3. By the following resolutions adopted by its Board of Directors, duly adopted by unanimous written consent of the members thereof on December 20, 2011, Parent determined to merge Subsidiary into itself in a merger (the "*Short Form Merger*"), effective as set forth below:

"WHEREAS, an Agreement and Plan of Merger (the "*Merger Agreement*"), a Certificate of Ownership and certain other agreements and other writings to accomplish the Short Form Merger (collectively, the "*Merger Documents*") have been presented to the Cumming Construction Management, Inc.'s Board of Directors (the "*Board*") for approval;

"WHEREAS, the Board deems it advisable and in Cumming Construction Management, Inc.'s best interest to approve the Short Form Merger, Cumming Construction Management, Inc.'s entry into the Merger Agreement and the consummation of the transactions contemplated thereby.

"NOW, THEREFORE, BE IT RESOLVED, that the Board hereby approves the Short Form Merger and the Merger Documents substantially in the form submitted to the Board.

"RESOLVED FURTHER, that Cumming Construction Management, Inc. merge Southern Management Group, Inc., its wholly owned subsidiary corporation, into itself and assume all its obligations pursuant to California Corporations Code Section 1110"

4. The proposed Short Form Merger and its principal terms have been adopted, approved, and acknowledged by the Board of Directors of Parent in accordance with the laws of the State of California.
5. The effective date of the Short Form Merger shall be December 31, 2011.
6. We further declare under penalty of perjury under the laws of the State of California that the matters set forth above in this certificate are true and correct to our own knowledge.

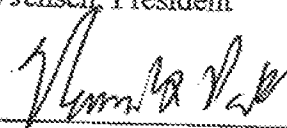
