by virtue of special power of attorney, the signature affixed thereto authenticated on 27th November 2012 by Notary Public practising in the Republic of Panama, Diomede E doardo Cerrudi, incorporating the apostil affixed on 27th November 2012,

(hereinafter referred to as the "TRANSFEROR");

of the other part

- **FEDERICA PIVA**, born in Pederobba (TV) on 17th June 1972, with address for service as stated below, in her capacity as Managing Director and representing the company:

"NORTHWAVE S.r.l.", with registered office in Pederobba (TV), Via Levada 145, capital stock Euro 200,000.00 (two hundred thousand), fully paid-up, tax code and Treviso Companies Registry number 01572560991,

vested with the necessary powers by operation of the articles of association currently in force and the resolution of the Board of Directors passed on 4th May 2010,

(hereinafter referred to as the "TRANSFeree");

WHEREAS

- the company "BUSINESSTONE LLC" is the title-holder of the trademarks and trademark applications listed in the document appended to this deed as Attachment A, thereby forming an integral and substantial part thereof and whose accuracy is warranted by the TRANSFEROR (hereinafter referred to jointly as the "Trademarks");

- the TRANSFEROR does not wish to incur further expenses in maintaining the validity and/or extending the scope of the Trademarks to other countries;

- the TRANSFeree wishes to acquire full and exclusive title to the Trademarks, together with all rights and interests attached thereto.

On the basis of the foregoing, it is hereby agreed and stipulated as follows.

1) The preambles form an integral and substantial part of this deed.

2) the company "BUSINESSTONE LLC", represented in the manner described herein, transfers and sells to the company "NORTHWAVE S.r.l." which, acting through the duly authorised representative indicated herein, accepts and acquires full and exclusive title to the Trademarks, together with all rights, entitlements and interests attached thereto.

3) The TRANSFEROR company warrants that it has not transferred or charged any right pertaining to the Trademarks in favour of third parties.

4) The TRANSFEROR expressly and irrevocably transfers to the TRANSFEREE, who accepts:
- the right to file an application for intellectual property rights relating to the Trademarks in any country;
- the sole right to exploit the Trademarks commercially in all or any countries to which its scope can be extended, without any reserve or limitation.

5) The TRANSFEROR agrees to recognise that any rights stemming from any trademark application filed in any country that claims the priority of the Trademarks is vested exclusively in the TRANSFEREE.

6) The TRANSFEROR agrees to sign any document that may prove necessary in order to permit the TRANSFEREE to extend the scope of the Trademarks anywhere in its exclusive name, to sign any document that may prove necessary in order to register the Trademarks in the Transferee's name and to take any other measure necessary for this purpose.

7) The price for this transfer has been fixed by the parties at Euro () which the TRANSFEROR declares it has already received from the TRANSFEREE by bank transfer for the sum of Euro () made on 28th November 2012, as evidenced by the document appended to this deed as Attachment B, thereby forming an integral part thereof, therefore issuing, in favour of the TRANSFEREE, full and final receipt of settlement of the amount due.

The parties relieve the authenticating Notary of the task of verifying the exact consistency of the subject matter of this deed.

8) The TRANSFEROR and the TRANSFEREE confirm that they agree that this deed should be registered at the Italian Patent and Trademarks Office (UIBM), the World Intellectual Property Organisation (WIPO), the Office for Harmonization on the Internal Market (OHIM), as well as all competent bodies, the costs incurred being charged to the TRANSFEREE.

9) This deed will be registered at the Inland Revenue Agency and be subject to the relevant tax.

The costs are borne exclusively by the TRANSFEREE.

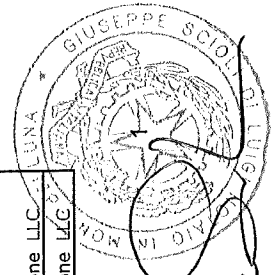

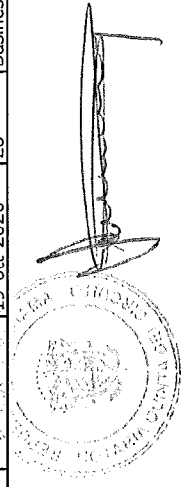

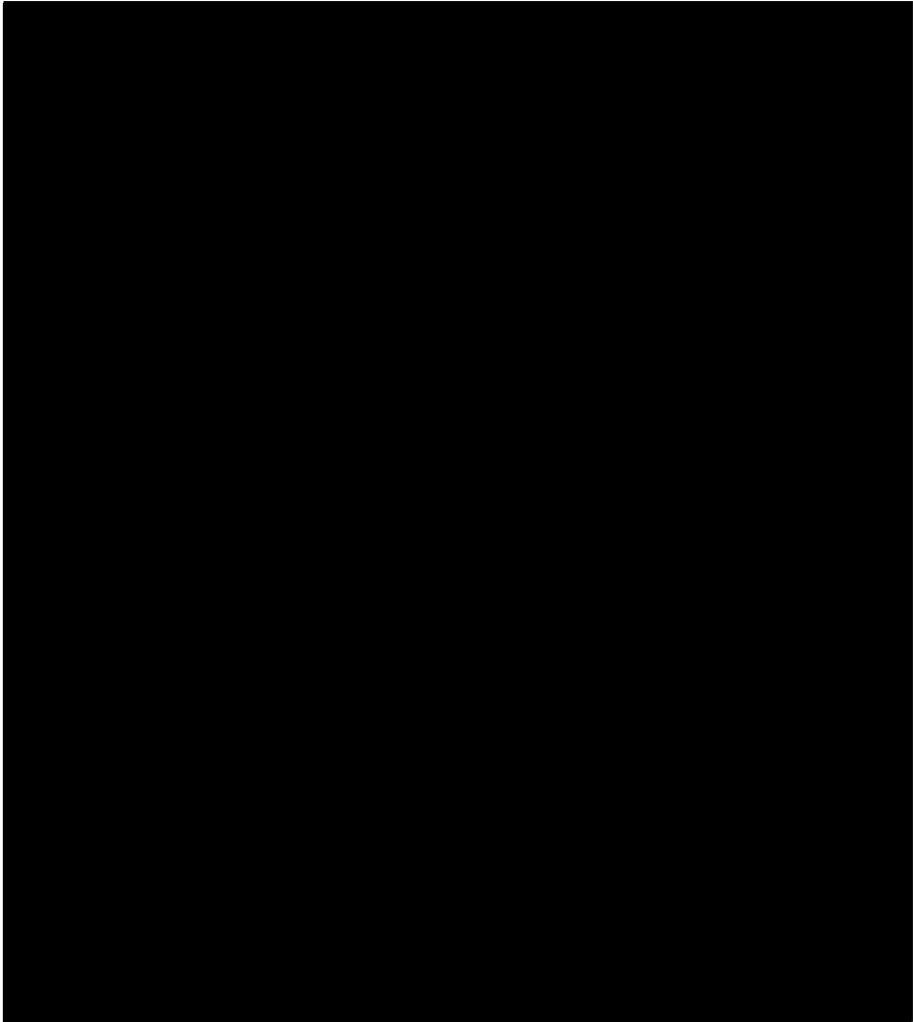
