TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement") dated as of June 6, 2013 made by National Hockey League, an unincorporated association not for profit ("Granting Party"), whose address is 15th Floor, 1185 Avenue of the Americas, New York, New York 10036, to CITIBANK, N.A., a national banking association, as Agent for the Secured Parties (as defined and as provided in the Amended and Restated Credit Agreement described below) (the "Agent"), whose address is One Court Square, 29th Floor, Long Island City, New York 11120.

PRELIMINARY STATEMENT:

WHEREAS, the Granting Party has executed and delivered that certain Amendment No. 2 to Third Amended and Restated Credit Agreement, Amendment No. 1 to Amended and Restated Security Agreement (US) and Amendment No. 1 to Amended and Restated Security Agreement (Canada) of even date herewith among the National Hockey League, an unincorporated association not for profit, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Interactive CyberEnterprises, LLC, the lenders party thereto and Citibank, N.A. as agent for such lenders (as amended or restated from time to time the "Amended and Restated Credit Agreement;

WHEREAS, as a condition, among others, to the Lenders' obligations to make Loans under the Amended and Restated Credit Agreement, the Granting Party and each of the Borrowers and the other Guarantors have, executed and delivered certain Amended and Restated Security Agreements, dated as of March 17, 2011 (as amended or restated from time to time, the "Security Agreement") (all capitalized terms not defined herein shall have the meanings set forth in the Security Agreement).

WHEREAS, in furtherance of the obligations of the Granting Party under such Security Agreement and in order to record the security interest in certain intellectual property of the Granting Party granted to the Agent therein, the Agent has required the Granting Party to execute and deliver this Agreement for filing in the United States Patent and Trademark Office.

NOW THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Granting Party hereby agrees with Agent as follows:

SECTION 1. Grant of Security Interest. The Granting Party hereby grants to the Agent for the benefit of the Secured Parties as security for the prompt and complete payment and performance in full when due (whether at stated maturity, acceleration or otherwise) of all the Secured Obligations of the Grantor, a security interest in and continuing Lien, on its respective right, title and interest (but not its obligations) in, to and under all of the following, in each case, whether now held, owned or existing or hereafter acquired or arising, and wherever located: all United States and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, trade styles, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing, all renewals of any of the foregoing, all of the goodwill of the business connected with the use of

and symbolized by the foregoing, the right to sue for past infringement or dilution of any of the foregoing or for any injury to goodwill, and all proceeds of the foregoing, including license royalties, income, payments, claims, damages, and proceeds of suit ("Trademarks"), including but not limited to those U.S. registered trademarks listed on Exhibit A attached hereto and incorporated herein by this reference; provided, however, notwithstanding anything herein to the contrary, in no event shall the security interest granted under this Agreement attach to, and the Trademarks shall not include, any Excluded Collateral, including but not limited to: any lease, license, contract, property rights or agreement to which any Granting Party is a party or any of its rights or interests thereunder if and for so long as the grant of such security interest shall constitute or result in (i) the abandonment, invalidation or unenforceability of any right, title or interest of any Granting Party therein, or (ii) a breach or termination pursuant to the terms of, or a default under, any such lease, license, contract, property rights or agreement in each case of clause (i) and (ii) above, other than to the extent that any such action or term would be rendered ineffective pursuant to Sections 9-406, 9-407, 9-408 or 9-409 of the UCC (or any successor provision or provisions) of any relevant jurisdiction; or Internet domain names that include indicia of any of the Member Clubs.

SECTION 2. Governing Document. This Agreement is governed by the Security Agreement, to which reference should be made for a full description of the rights and remedies of the Agent with respect to the Trademarks. In the case of a conflict or inconsistency between any provision of this Agreement and any provision of the Security Agreement, the provisions of the Security Agreement shall control and govern.

SECTION 3. Termination. This Agreement shall terminate on or after the Termination Date.

SECTION 4. Governing Law. THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE CONSTRUED IN ACCORDANCE WITH AND BE GOVERNED BY THE LAWS OF THE STATE OF NEW YORK AS MORE FULLY SET FORTH IN SECTION 9.1 OF THE SECURITY AGREEMENT (WHICH SECTION 9.1 IS INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS, AS THOUGH FULLY SET FORTH HEREIN).

SECTION 5. WAIVER OF TRIAL BY JURY. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE GRANTING PARTY (AND THE AGENT, BY THE ACCEPTANCE HEREOF), HEREBY IRREVOCABLY WAIVES ALL RIGHT OF TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR ANY MATTER ARISING HEREUNDER.

IN WITNESS WHEREOF, Granting Party has caused this Trademark Security Agreement to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
