RELEASE AND REASSIGNMENT OF CERTAIN  
TRADEMARKS AS SECURITY

WHEREAS, Fairchild Industries, Inc., a Delaware corporation (the "Company"), owns the trademarks described in the attached Schedule A (the "Marks") for which there are recordings in the United States Patent and Trademark Office under the numbers set forth in the attached Schedule A; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent does hereby terminate its security interest in, and reassign and reconvey to the Company, the Marks and (a) all renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements or dilutions thereof, (c) the right to sue for past, present and future infringements and dilutions thereof, (d) to the extent permitted by law, all of the Company's rights corresponding thereto throughout the world and (e) the goodwill of the Company's business connected with and symbolized by the marks.
