Holdco, Winzip Computing S.L.U., Winzip Holdings Spain, S.L.U., Intervideo, Inc., Intervideo Digital Technology Corp., Corel US Holdings, LLC, as recorded by the U.S. Patent & Trademark Office with respect to Patents on December 28, 2006 at Reel/Frame 018688/0199 and with respect to Trademarks on December 28, 2006 at Reel/Frame 3452/0028 (collectively, the “Security Interest”);


WHEREAS, Assignor desires to release its security interest in the Collateral.
