This Termination governs only the Security Agreement and does not and shall not be construed to affect any other agreement between the parties.



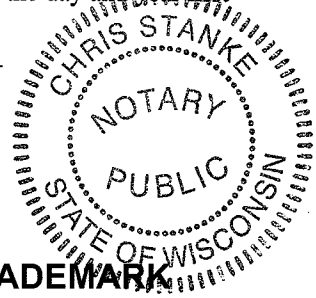
