**TRADEMARK ASSIGNMENT**

This Trademark Assignment Agreement is made and entered into as of March 29, 2013 (the "Effective Date"), by and between Sky Valley Foods, Inc., a North Carolina corporation with an address of 878 Firetower Road, Yanceyville, North Carolina 27379 ("Assignor"), and Sky Valley Foods LLC, a Delaware limited liability company with an address of 878 Firetower Road, Yanceyville, North Carolina 27379 ("SVF LLC").

Assignor desires to convey, transfer, assign, and deliver to SVF LLC all of its rights, title, and interest in and to the Marks and the goodwill of the business associated therewith and symbolized thereby, including the Registrations and Applications; and SVF LLC desires to acquire the Marks and the goodwill of the business associated therewith and symbolized thereby, including the Registrations and Applications.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby conveys, transfers, assigns, and delivers to SVF LLC all of Assignor's rights, title, and interest in, to, and under the Marks, including all common law rights connected therein; together with the goodwill of the business symbolized thereby and associated therewith, and any registrations of and applications to register the Marks, including the Registrations and Applications; and together with all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Marks, and with the right to sue for and collect damages.

Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing,

completing, or vesting in SVF LLC full rights, title, and interest in and to the Marks.


