ASSIGNMENT AGREEMENT

WHEREAS, Queensway Investment Holdings, LLC, a Delaware <sup>limited liability company</sup> corporation, having an address at 13363 Portofino Drive, Del Mar, California 92014 (hereinafter "ASSIGNOR"), is the owner of U.S. Trademark Application No. 77/640,481 for the LA GRANJA Mark for wines; and

WHEREAS, National Grange of the Order of Patrons of Husbandry, a District of Columbia non-profit corporation, having an address at 1616 H Street NW, Washington, District of Columbia 20006 (hereinafter "ASSIGNEE"), is desirous of becoming the owner by assignment of the LA GRANJA Mark, as well as U.S. Trademark Application No. 77/640,481 (the "LA GRANJA Application"); and

WHEREAS, ASSIGNOR desires to transfer to ASSIGNEE any and all right, title, interest and goodwill it holds in and to the LA GRANJA Mark as well as the LA GRANJA Application;

NOW, THEREFORE,

1. ASSIGNOR warrants that it is the owner of the LA GRANJA Mark as well as the LA GRANJA Application; and that there is no challenge to such ownership pending and not resolved, as U.S. Trademark Trial and Appeal Board Proceeding No. 91192184, brought by Assignee, was withdrawn without prejudice by consent of Assignor and Assignee, under the terms of a Settlement Agreement.
2. ASSIGNOR warrants that no security interest is presently outstanding in favor of any third party with respect to any of its rights in the LA GRANJA Mark or the LA GRANJA Application.
3. ASSIGNOR agrees to provide any documentation or assistance that ASSIGNEE may reasonably request in securing and perfecting the rights to be transferred pursuant to this Agreement.
4. In consideration of the sum of Five Thousand Dollars (\$5,000.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby sell, assign and transfer to ASSIGNEE, its successors and assigns, all rights, title and interest in and to the LA GRANJA Mark and LA GRANJA Application, together with all of the goodwill of the business symbolized by the LA GRANJA Mark.
5. ASSIGNOR further assigns to ASSIGNEE all rights to damages or profits, due or accrued, arising out of past infringement of the Marks or injury to the goodwill connected with use of the Marks.
6. This Agreement represents the entire agreement between the parties regarding assignment of the Marks, and it supersedes any prior oral or written agreement or understanding between the parties on that subject.

7 This Agreement is binding upon the parties, as well as their successors, assigns, officers and all those in concert or privity with them.

8 The assignment contemplated herein shall be deemed effective as of the date indicated below.
