TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, COLD STONE CREAMERY, INC., an Arizona corporation (the "Grantor"), is the owner of record of the trademarks and applications listed on the attached Exhibit A, now issued or pending in the United States Patent and Trademark Office (the "Trademarks"); and
