

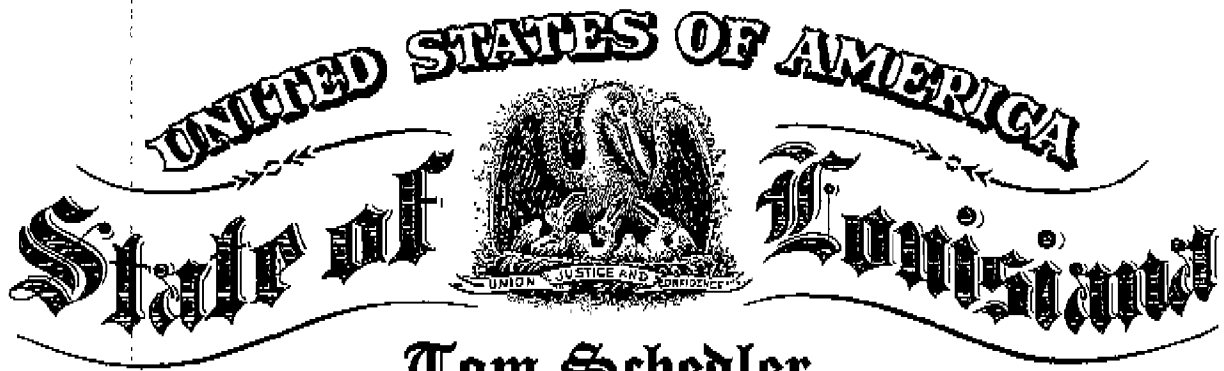

Fifth: The executed agreement of merger is on file at the principal place of business of The Shaw Group Inc., the surviving corporation, at:

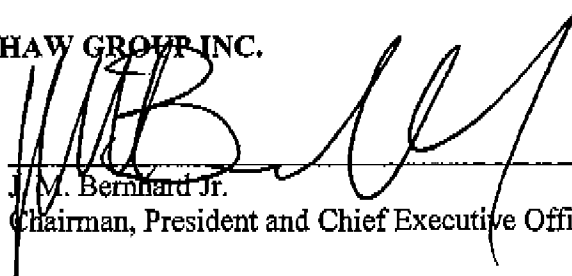
