ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this "Assignment") is made and entered into as of the 12 day of June, 2013 (the "Effective Date"), by and between WISCONSIN NOTE INVESTORS, LLC, a Delaware limited liability company ("Assignor"), and SELLARS ABSORBENT MATERIALS, INC., a Wisconsin corporation ("Assignee").

RECITALS:

A. Assignee and its subsidiaries previously assigned, conveyed and transferred to Assignor all of their right, title and interest in and to certain "Intellectual Property", as defined and identified on Exhibit A attached hereto and as further identified in this Assignment, pursuant to that certain Assignment of Intellectual Property dated as of December 30, 2011.

B. In consideration of the repurchase of certain assets by Assignee and its subsidiaries pursuant to the exercise of that certain repurchase option set forth in that certain Master Lease Agreement dated as of December 30, 2011, to which Assignor, Assignee, and Assignee's then current subsidiaries were parties, and the payment by Assignee to Assignor of the amounts due in connection with such repurchase option (the "Repurchase Payment"), Assignor hereby will transfer, assign and convey all Assignor's right, title and interest in and to the Intellectual Property back to Assignee.

In consideration of the payment by Assignee to Assignor of the Repurchase Payment and for other good and valuable consideration as set forth herein, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. **Assignment of Intellectual Property.** Assignor hereby sells, assigns, and transfers to Assignee all of its worldwide right, title, and interest in and to the Intellectual Property, including all rights therein and related thereto, which includes but is not limited to the following: (a) all patent rights, patents, patent applications, and invention disclosures, and all patents that may issue thereon; (b) all copyright rights, copyright registrations, and applications for copyright registrations; (c) all trademarks, service marks, design marks, slogans, trade dress, trade names, corporate names, Internet domain names, and any applications or registrations therefor or relating thereto, and all related goodwill; (d) all trade secrets and confidential information, including but not limited to business information, formulas, technology, processes, methods, know-how, computer programs, customer lists, and vendor lists; (e) all rights of publicity and privacy, including but not limited to the rights to use names, likenesses, and identities; and (f) all patents and trademarks, and all registrations and applications therefor, identified in Exhibit B and Exhibit C to this Assignment. This assignment includes all rights in and to all income, royalties, damages, and other remedies now or hereafter due or payable with respect to any of the Intellectual Property, and the right to sue, counterclaim, and recover for any present and future (but not past) infringements of the Intellectual Property, as fully and entirely as such rights would have been held and enjoyed by Assignor this assignment had not been made.

2. **Limited Representation and Warranty.** The assignment made by Assignor hereunder is made without representation or warranty by Assignor except that Assignor hereby represents and warrants to Assignee that Assignor has not previously assigned or encumbered any of its right, title or interest to any of the Intellectual Property.

3. **Additional Documents.** Upon Assignee's request and at Assignee's sole cost, Assignor will make, execute, and deliver any and all other documents, and do all lawful acts and things, as may be necessary or appropriate, in Assignee's reasonable judgment, to secure, vest, maintain, perfect, or record this assignment of the Intellectual Property.

4. **Miscellaneous.**

(a) **Headings.** The section headings used herein are inserted for convenience only and shall not affect in any way the meaning or interpretation of this Assignment.

(b) **Governing Law.** This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin.






