2. Binding Effect and Governing Law. This Assignment is binding on Assignors and their successors and assigns, and will inure to the benefit of Assignee and its successors and assigns, and shall be construed and enforced in accordance with the laws of the State of Delaware without regard to the conflict or choice of law rules.


