TRADEMARK ASSIGNMENT

This Trademark and Service Mark Assignment ("Assignment") is entered into as of June 7, 2013 ("the Effective Date") between Molenaar, LLC, a Minnesota limited liability company ("Assignor") and Fey Industries, Inc., a Minnesota corporation ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee any and all right, title, and interest in and to the Marks together with any and all goodwill of the business embodied in the Marks. Assignor hereby assigns to Assignee any and all right, title, and interest in and to the Cancelled Registrations, to the extent that Assignor has such rights. Assignor represents and warrants that it has full power to enter into and perform this Assignment, that it has not granted any person or entity any interest in the Mark and that there is no pending litigation or dispute in any jurisdiction concerning the use, validity, or ownership of the Mark. Assignor agrees to take all actions, execute additional documents and to otherwise cooperate as requested by Assignee as necessary to confirm or perfect the assignment of all rights, title, and interest in and to the Marks.
