RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 13, 2013 in favor of Janorpot, LLC ("Grantor") by Rabobank International (the "Security Agent"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, Grantor and the Security Agent entered into that certain Security Agreement by and between Grantor, the Security Agent, and the other parties thereto (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor granted to the Security Agent a security interest in all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Supplement to Security Agreement (Trademarks) dated October 22, 2007 (the "Supplement") for the purpose of recording such security interest with respect to the Collateral (as such term is defined in the Supplement), which included those items set forth on Schedule A hereto, with the United States Patent and Trademark Office;

WHEREAS, the Supplement was recorded with the United States Patent and Trademark Office on October 29, 2007, at Reel 3649, Frame 0827; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Security Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby, on behalf of itself and the Lenders (i) terminates the Supplement, (ii) terminates, cancels and releases any and all security interests it has against the Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Collateral.


The Security Agent shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.


