

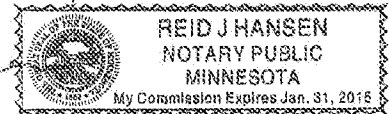


They took the 26 month old document and went to a different attorney to have it filed. They did not inform me, again a breach of contract. I have attached with this affidavit. Rivie, please find attached pdf. It shows that TrailChips LLC is in tax arrears in the State of Delaware. In confirmation with law firm, the original tax or the re filed tax due no later than June 1st 2012 was paid. The law firm will not do any business with or on behalf of TrailChips LLC. This in addition to previous e mails in which you were notified that Eaton & Van Winkle LLP was not fully paid for all services and had ceased operating on

our behalf. The fact that they no longer will do work for TrailChips LLC has caused the transfer of the trademark to the LLC not to happen. It has also been brought to your attention that money was transferred from the Chase Checking Business TrailChips LLC account to the personal account of Meyer Futersak . Money was also transferred from that account to a business account run by you and Meyer named Kosher Shock. These transactions violate article 2 , letter (f) RN (i), (iii), (iv), (v), (vii), (viii), and (g). Please concur that the business should be dissolved and at the time of dissolution that you will be reimbursed \$20,163.74. That number is down from previous number because I had not known that \$2,400 of monies was transferred to Meyer's personal account.

I have received paper work from State of Delaware to dissolve the LLC and will do so unilaterally and as a matter of ethical business practice. I would rather do it in conjunction with the above agreed reimbursement to you, but it will be done. I have received counsel to that due to the questionable behavior or Meyer Futersak, not to proceed in any way shape of form. Please respond with agreement forthwith.
