CERTIFICATE OF LEGAL SUCCESSION

I, Friedel Maul, notary public in Wiesbaden, hereby certify, after having inspected the Commercial Register of the District Court at Wiesbaden on 29 October 2009, that Cytec Surface Specialties Germany GmbH having its registered office in Wiesbaden is registered there under the number HRB 20875. It is furthermore recorded in the Commercial Register that Vianova Resins Germany Management GmbH (Wiesbaden District Court no. HRB 11156) merged with Cytec Surface Specialties Germany GmbH in terms of the merger agreement of 28.07.2009 together with the confirmatory resolutions of the interested title-holders of even date therewith.

Vianova Resins Germany Management GmbH (Wiesbaden District Court no. HRB 11156) as personally liable partner and Cytec Surface Specialties Germany GmbH having its registered office in Wiesbaden (formerly trading under the name Viking Resins Germany Holding GmbH) as limited partner were the sole shareholders of Cytec Surface Specialties Germany GmbH & Co KG having its registered office in Wiesbaden, formerly registered in the Commercial Register of the District Court at Wiesbaden under the number HRA 4471, which fact I certify on the basis of the inspection I made of the Commercial Register of the Wiesbaden District Court on 28.07.2009. As a consequence of the merger solemnly recorded in my deed no. FM 277/2009 on 28.07.2009 between the personally liable partner (Vianova Resins Germany Management GmbH) with the limited partner Cytec Surface Specialties Germany GmbH, Cytec Surface Specialties Germany GmbH & Co KG ceased to exist and its net assets accrued to the "remaining limited shareholder", Cytec Surface Specialties Germany GmbH, by way of universal succession with all assets and liabilities together with all rights and duties. By operation of law, Cytec Surface Specialties Germany GmbH was thereby subrogated in all legal positions held by Cytec Surface Specialties Germany GmbH & Co KG. The universal succession came into effect upon the coming into effect of the merger on 31.08.2009.

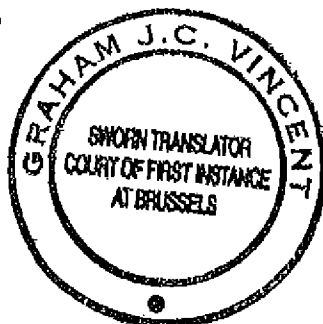

RECHTSNACHFOLGEBESCHEINIGUNG

Ich, der Wiesbadener Notar Friedel Maul, bescheinige hiermit aufgrund Einsichtnahme in das Handelsregister des Amtsgerichts Wiesbaden am 29. Oktober 2009, dass dort unter HRB 20875 die Cytec Surface Specialties Germany GmbH mit Sitz in Wiesbaden eingetragen ist. Eingetragen ist ferner im Handelsregister, dass die Vianova Resins Germany Management GmbH (Amtsgericht Wiesbaden HRB 11156) nach Maßgabe des Verschmelzungsvertrages vom 28.07.2009 sowie der Zustimmungsbeschlüsse der beteiligten Rechtsträger vom selben Tag auf die Cytec Surface Specialties Germany GmbH verschmolzen wurde.

Die Vianova Resins Germany Management GmbH (AG Wiesbaden HRB 11156) als persönlich haftende Gesellschafterin und die Cytec Surface Specialties Germany GmbH mit Sitz in Wiesbaden (ehemals firmierend unter Viking Resins Germany Holding GmbH) als Kommanditistin waren die alleinigen Gesellschafter der Cytec Surface Specialties Germany GmbH & Co. KG mit Sitz in Wiesbaden, ehemals eingetragen im Handelsregister des Amtsgerichts Wiesbaden unter HRA 4471, was ich aufgrund am 28.07.2009 erfolgter Einsichtnahme in das Handelsregister des Amtsgerichts Wiesbaden bescheinige. Durch die zu meiner Urkunde Nr. FM 277/2009 am 28.07.2009 beurkundete Verschmelzung der persönlich haftenden Gesellschafterin (Vianova Resins Germany Management GmbH) auf die Kommanditistin Cytec Surface Specialties Germany GmbH ist die Cytec Surface Specialties Germany GmbH & Co. KG erloschen und ihr Vermögen im Wege der Gesamtrechtsnachfolge mit allen Aktiva und Passiva sowie allen Rechten und Pflichten der „übrig gebliebenen Kommanditistin“ Cytec Surface Specialties Germany GmbH angefallen.
