**DEED OF GIFT**

THIS DEED OF GIFT made as of the 10<sup>th</sup> day of June, 2013 (the "Effective Date"),

BETWEEN:

**RODNEY WEBSTER**

(the "Rodney")

AND:

**RODNEY WEBSTER and LAURA WEBSTER**

(collectively, the "Donees")

WHEREAS:

A. Rodney is the legal and beneficial owner of the trademarks described in Schedule A hereto (the "Trademarks") and all goodwill associated with the Trademarks (collectively, the "Property");

B. Laura Webster is the spouse of Rodney; and

C. Rodney wishes to transfer and assign all of his legal and beneficial interest in and to the Property to the Donees, as joint tenants with right of survivorship, as a gift.

NOW THEREFORE this Deed witnesses that:

1. **Gift** - For no consideration, Rodney hereby absolutely and irrevocably makes a gift by transferring and assigning all of his legal and beneficial interest in and to the Property to the Donees, as joint tenants with right of survivorship, by way of gift (the "Gift").

2. **Acceptance** - The Donees hereby acknowledge and accept the Gift from Rodney as of the Effective Date.

3. **Further Assurances** - Rodney shall execute all other documents and instruments and do all other things necessary to complete the Gift and to carry out the terms of this Deed including without limitation obtaining the necessary consents, approvals, permissions and agreements required in connection with the transfer of all of Rodney's legal and beneficial interest in and to the Property to the Donees, as joint tenants with right of survivorship.

4. **Time** - Time shall be of the essence of this Deed.

5. **Governing Law** - This Deed shall be governed by and construed in accordance with the laws of the Province of British Columbia.

6. **Enurement** - This Deed shall be binding upon and shall enure to the benefit of the parties hereto and their respective heirs, executors, administrators, successors and assigns.

7. **Counterparts** - This Deed may be executed in any number of counterparts, each of which when executed and delivered (by facsimile or otherwise) will be deemed to be an original, and all of which together will constitute one document.
