

Correction by Declaration

On June 4, 2013, the undersigned, on behalf of Penguin Group (USA) LLC, submitted to the Assignment Division a certificate of conversion of Penguin Group (USA) Inc. from a Delaware corporation to Penguin Group (USA) LLC, a Delaware limited liability company, with a cover sheet requesting that this document be recorded against 121 trademark registrations and applications. The document was recorded on June 4, 2013 at Trademark Reel 005039/Frame 0728.

The registrations against which the cover sheet requested recordation erroneously included No. 3959952 for the mark BLACKTOP COWBOYS. This mark and registration had previously been assigned by Penguin Group (USA) Inc. to Lori G. Armstrong, aka Lorelei James. This earlier assignment to Ms. Armstrong, executed on May 5, 2011, had been recorded at Trademark Reel 4610/Frame 0319. As of June 4, 2013, Penguin Group (USA) LLC was not, and is not now, the owner of Registration No. 3959952.
