WHEREAS, Assignor owns the Trademarks listed in Schedule A hereto (the "Trademarks"); and



The Assignor undertakes and agrees to execute such further documents as may reasonably be required to permit the Assignee to obtain additional registrations and renewals of the Trademarks and the recording of this trademark Assignment. Assignor hereby irrevocably nominates, constitutes and appoints Assignee as their true and lawful attorney, with full power and authority in Assignee's name or in the name of the Assignor, with full power of substitution, to claim, demand payment or collect and enforce all rights, claims and interests transferred and assigned hereby, and to prosecute the same at law or in equity, and upon complete discharge thereof, to execute and deliver any and all necessary instruments of satisfaction and release, and to execute and deliver in Assignor's name any and all instruments necessary or appropriate to confirm Assignee's rights to the assets set forth herein.




