SUPPLEMENT NO. 1
TO TRADEMARK SECURITY AGREEMENT

This SUPPLEMENT No.1 dated as of June 24, 2013 (this "Supplement") is delivered to supplement the TRADEMARK SECURITY AGREEMENT dated as of September 30, 2010 (the "Trademark Security Agreement"), between CREATIVE ARTISTS AGENCY, LLC and CAIC, LLC (the "Grantor"), on the one hand, and BANK OF AMERICA, N.A., as Administrative Agent for the Secured Parties (the "Administrative Agent"), on the other hand. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Trademark Security Agreement.



As used in the Trademark Security Agreement, the terms "this Agreement," "this Trademark Security Agreement," "herein," "hereafter," "hereto," "hereof" and words of similar import, shall, unless the context otherwise requires, mean the Trademark Security Agreement as supplemented by this Supplement.
