## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of June 26, 2013 (the "Effective Date") by Deutsche Bank Trust Company Americas, as Revolving Collateral Agent (the "Collateral Agent"), in favor of Thilmany, LLC, a Delaware limited liability company (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Grant of Security Interest in Trademarks, dated as of February 1, 2011 (the "Trademark Security Agreement"), Grantor pledged and granted to the Collateral Agent, for the benefit of the Revolving Secured Parties, a security interest and continuing lien in and to all of its right, title and interest in, to and under the Trademark Collateral, including, without limitation, its Trademarks and Trademark applications listed on Schedule A attached hereto which security interest was recorded on February 10, 2011 at Reel/Frame 4476/0222 with the U.S. Patent and Trademark Office. Each capitalized term used herein without definition shall have the meaning ascribed to such term in the Trademark Security Agreement.

**WHEREAS**, pursuant to the terms and conditions of that certain Unit Purchase Agreement, dated as of April 21, 2013 (the "Unit Purchase Agreement"), and in accordance with that certain Revolving Credit and Guaranty Agreement, dated as of February 1, 2011, Packaging Dynamics Corporation, a Delaware corporation and the immediate parent of Grantor (the "Company"), has sold all of the issued and outstanding membership interests of Grantor and all assets of Grantor including, without limitation, the trademarks and trademark applications listed on Schedule A attached hereto (the "Released Trademarks").

**WHEREAS**, pursuant to the terms and conditions of the Unit Purchase Agreement, Grantor has requested that the Collateral Agent release its security interest in the Released Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all collateral pledge, grant, assignment, lien on and security interests it has in and to the Released Trademarks.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Released Trademarks, it hereby assigns and transfers such rights, title or interest to the Released Trademarks without representation, covenant or warranty, express or implied, and without recourse to it of any kind.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Released Trademarks. The Collateral Agent hereby authorizes Grantor to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of any security interest of the Collateral Agent in the Released

Trademarks, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

The Collateral Agent shall take all further actions, and provide to the Grantor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor or the Company, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release may be executed in any number of counterparts, each of which when so executed and delivered, shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
