TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (“Assignment”) is entered into as of November 15, 2012, by Business Intelligence Solutions Safe B.V., a Dutch private limited liability company (“Assignor”), in favor of New BIS Safe Luxco, a Luxembourg private limited company (*société à responsabilité limitée*) (“Assignee”) (collectively, the “Parties” and each a “Party”).

WHEREAS, Assignor and Assignee are parties to the Transaction Agreement, dated November 1, 2012 (the “Transaction Agreement”), pursuant to which Assignor has agreed to assign to Assignee and Assignee has agreed to acquire certain assets of Assignor, including, without limitation, the trademark registrations and applications for registration therefor identified and set forth on Schedule A attached hereto (such trademark registrations and applications, the “Marks”); and

WHEREAS, pursuant to the Transaction Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor’s right, title and interest in and to the Marks, including any copyright in the Marks, and all goodwill associated with the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, Assignor hereby agrees:

1. Assignment. Assignor hereby sells, transfers, assigns, conveys and delivers to Assignee, and its successors and assigns, and Assignee hereby acquires from Assignor and accepts the sale, assignment, conveyance, transfer and delivery of, all of Assignor’s right, title and interest in, to and under the Marks, together with (i) all of the goodwill associated thereto, (ii) any and all of the copyrights in the Marks, (iii) all rights to sue at law or in equity for infringements, misappropriations or other violation of any law with respect to any of the Marks whether for any past, present or future infringement, misappropriation or other violation of the Marks, and (iv) all rights as opponent in any opposition proceedings.
2. Ownership. Assignor hereby acknowledges and agrees that from and after the date hereof, Assignee shall be the exclusive owner of all of Assignor’s right, title and interest in, to and under the Marks.
3. Further Assurances. Assignor shall, at Assignee’s cost and expense, take all actions and execute and deliver such other documents that Assignee may reasonably request to effect the terms of this Assignment and to perfect Assignee’s title in, to and under the Marks, including, without limitation, entering into individual trademark assignment agreements for the purposes of evidencing and recording Assignee’s rights in the Marks and filing such assignment agreements at national and regional trademark registration offices.
4. Recordation. Assignor hereby expressly authorizes Assignee to record this Assignment at the United States Patent and Trademark Office, the Office for Harmonization of the Internal Market and at any similar office or agency anywhere in the world.


5. Miscellaneous. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware applicable to contracts made and to be performed entirely in such state without regard to principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of Delaware applicable hereto. This Assignment may not be supplemented, altered or modified in any manner except by a writing signed by the Parties hereto. The failure of any Party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. In the event of a conflict between the provisions herein and the terms and conditions of the Transaction Agreement, the terms and conditions of the Transaction Agreement shall govern. This Assignment shall bind and inure to the benefit of the respective Parties and their assigns, transferees and successors. This Assignment and any amendments hereto may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.
