**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release"), dated as of ~~June 28~~, 2013, is made by **SOCIÉTÉ GÉNÉRALE** as security agent and trustee (the "Security Agent"), under the Senior Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement as defined below).

**WHEREAS**, **WP ROAMING III S.À.R.L.**, the Security Provider (as defined below), the other guarantors party thereto, the borrowers party thereto, the Security Agent and the various financial institutions party thereto as lenders thereunder (each individually a "Lender," and collectively, the "Lenders") entered into that certain Senior Credit Agreement, dated as of May 3, 2007 (as amended from time to time, the "Senior Credit Agreement");

**WHEREAS**, in connection with the Senior Credit Agreement, and pursuant to the Security Agreement, dated as of June 28, 2007, by Cibernet Corporation (the "Security Provider") and Société Générale in favor of Société Générale, as Security Agent on its own behalf and as security agent for each of the Secured Parties, (the "Security Agreement"), the Security Provider granted security interests in certain intellectual property owned by the Security Provider listed on Annex I attached hereto (collectively, the "Collateral"); and


**WHEREAS**, the Security Agreement was recorded in the U.S. Patent and Trademark Office (the "USPTO") on August 3, 2007 and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Security Agent hereby terminates, releases, and discharges without representation, recourse or warranty whatsoever, all of its lien on, and security interest in and to, all of the right, title and interest to and under the Collateral, including but not limited to the intellectual property listed on Annex I, whether granted pursuant to the Security Agreements or any other agreement or document delivered by the Security Provider to the Security Agent in connection with the Senior Credit Agreement, and the Security Agent hereby reassigns, without representation, recourse and warranty whatsoever, any and all such right, title and interest (if any) that the Security Agent may have in the Collateral to the person legally entitled thereto.

Security Agent further agrees to execute and deliver to the Security Provider any and all further documents and instruments, and do any and all further acts which the Security Provider reasonably requests (at the Security Provider's sole cost and expense) in order to confirm this Release, so long as such requested documents, instruments and acts are not inconsistent with this Release and do not increase, decrease or otherwise affect the rights and obligations of Security Agent or any Lender hereunder or otherwise.

IN WITNESS WHEREOF, the Security Agent has executed this Release as of the date first above written.
