RELEASE OF PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT





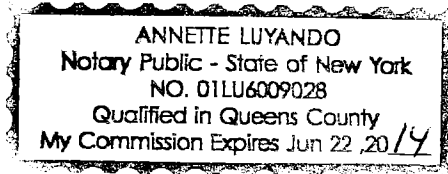
