**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of July 2, 2013, is made by General Electric Capital Corporation, as collateral agent ("Agent"), under that certain Credit Agreement, dated as of March 5, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with the Credit Agreement, and together with all general security agreements and intellectual property security agreements entered into in connection therewith or in connection with prior versions thereof, among Levlad, LLC and Arbonne International, LLC (the "Grantors"), the Lenders from time to time party thereto and General Electric Capital Corporation, as Administrative Agent and Collateral Agent, and any other parties thereto, the Lenders made credit extensions to the Credit Parties;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain Grants of Security Interests in U.S. Trademark Rights and Grants of Security Interests in U.S. Patent Rights described on Annex I attached hereto (collectively, the "Security Agreements"), the Grantor granted to Agent a security interest in certain trademarks and patents owned by them, including those listed on Annex I attached hereto (the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") on the dates and on the reels and frames as set forth on Annex I hereto.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and as agent for each other Lender, hereby terminates, releases and discharges without representation, recourse or warranty whatsoever, all of its security interest in and to all of its right, title and interest in the Intellectual Property Collateral (including all goodwill of the business connected with the use of, and symbolized by, all trademarks included in the Intellectual Property Collateral), granted pursuant to the Security Agreements, and Agent hereby retransfers and reassigns any and all such right, title and interest (if any) that Agent may have in the Intellectual Property Collateral to the applicable Grantor. The Agent hereby authorizes and requests that the USPTO record this Release, and Agent hereby authorizes the Grantors to file this Release on behalf of the Agent with the USPTO or any other relevant governmental authority.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
