## RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (this “**Release**”) is dated as of July 1, 2013, and entered into by AMF Bowling Centers, Inc. (a Virginia corporation) (“**Company**”), on behalf of itself and Citicorp USA, Inc., a Delaware corporation with its head office located at 250 West Street, New York, New York 10013, as collateral agent acting for the benefit of the Secured Parties (as defined in the Credit Agreement referred to below) (in such capacity, “**Collateral Agent**”), in favor of AMF Group Inc. (a Delaware corporation), AMF BCO-China, Inc. (a Virginia corporation), AMF BCO-France One, Inc. (a Virginia corporation), AMF BCO-France Two, Inc. (a Virginia corporation), AMF BCO-UK One, Inc. (a Virginia corporation), AMF BCO-UK Two, Inc. (a Virginia corporation), AMF Beverage Company of Oregon, Inc. (an Oregon corporation), AMF Beverage Company of W. Va., Inc. (a West Virginia corporation), AMF Bowling, Inc. (a Virginia corporation), AMF Bowling Centers China, Inc. (a Virginia corporation), AMF Bowling Centers International Inc. (a Virginia corporation), AMF Bowling Centers (Aust) International Inc. (a Virginia corporation), AMF Bowling Centers (Canada) International Inc. (a Virginia corporation), AMF Bowling Centers (Hong Kong) International Inc. (a Virginia corporation), AMF Bowling Centers Holdings Inc. (a Delaware corporation), AMF Bowling Centers Spain Inc. (a Delaware corporation), AMF Bowling Centers Switzerland Inc. (a Delaware corporation), AMF Bowling Holdings Inc. (a Delaware corporation), AMF Bowling Mexico Holding, Inc. (a Delaware corporation), AMF Group Holdings Inc. (a Delaware corporation), AMF Worldwide Bowling Centers Holdings Inc. (a Delaware corporation), Boliches AMF, Inc. (a Virginia corporation), Bush River Corporation (a South Carolina corporation), King Louie Lenexa, Inc. (a Kansas corporation), and their successors and assigns, having a place of business at 7313 Bell Creek Road, Mechanicsville, Virginia 23111 (the “**Grantors**”).

**WHEREAS**, reference is made to that certain Intellectual Property Security Agreement dated as of May 1, 1996 (as amended, restated, supplemented or otherwise modified from time to time, the “**Intellectual Property Grant**”) by Grantors in favor of Citicorp USA, Inc., an entity with its head office located at 250 West Street, New York, New York 10013, as collateral agent acting for the benefit of the Secured Parties (as defined in the Credit Agreement referred to below) (in such capacity, “**Collateral Agent**”). Capitalized terms used herein without definition have the meanings given to them in the Intellectual Property Grant.

**WHEREAS**, in connection with the Credit Agreement, dated as of May 1, 1996 (as amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among, the Grantors, the Collateral Agent, Arrangers, Syndication Agent, and the Lender Parties party thereto, the Grantors delivered the Intellectual Property Grant.

**WHEREAS**, pursuant to the Intellectual Property Grant, Grantors granted security interests in all of the Trademark Collateral (as defined below) to the Collateral Agent.

**WHEREAS**, the Intellectual Property Grant was recorded with the United States Patent and Trademark Office on June 7, 1996, at Reel/Frame: 1501/0773.

**WHEREAS**, the Grantors have no further obligations under the Credit Agreement and all liens and security interests under the Intellectual Property Grant have been terminated and released, including, without limitation, pursuant to that certain Order Confirming the Third Modified Joint Plan of Reorganization of AMF Bowling Worldwide, Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code entered by the United States Bankruptcy Court for the Eastern District of Virginia in Case Number 12-26495 on June 25, 2013 (the “**Confirmation Order**”).

**WHEREAS**, pursuant paragraph 104 of the Confirmation Order, the Company has been authorized to file all documentation necessary to evidence the releases and terminations set forth therein.

**WHEREAS**, the Company now desires to terminate and release the security interest in and lien on the Trademark Collateral.

**NOW, THEREFORE**, the security interest in and lien on the Trademark Collateral is hereby terminated, released, and discharged, and any rights the Collateral Agent may have in the Trademark Collateral pursuant to or in connection with the Intellectual Property Grant or otherwise is hereby reconveyed, transferred, and assigned to Grantors and their successors and assigns.

For purposes of this Release, “**Trademark Collateral**” means any and all right, title, and interest of each Grantor and its successors and assigns in and to the following, in each case whether now or hereafter existing, whether now owned or hereafter acquired and wherever the same may be located:


- (a) all of such Grantor’s trademarks, including without limitation, the trademark registrations set forth on Schedule A hereto (collectively, the “**Trademarks**”);
- (b) all goodwill of the business associated with the Trademarks; and
- (c) all products and proceeds of the Trademarks, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any intellectual property license, including the right to receive any damages, (ii) injury to the goodwill associated with any Trademark or (iii) right to receive license fees, royalties and other compensation under any intellectual property license.
