TERMINATION OF TRADEMARK SECURITY INTEREST

This TERMINATION OF TRADEMARK SECURITY INTEREST, dated as of July 2, 2013, is made by PNC Bank, National Association, on behalf of itself and as administrative agent for the Lenders as defined in that certain Patent, Trademark and Copyright Security Agreement dated May 14, 2010 as signed by Grantors ("the Security Agreement") (the "Secured Party").

WHEREAS, Taggart Global USA, LLC, a Delaware limited liability company ("Parent") and Taggart Global China, LLC, a Pennsylvania limited liability company ("Taggart China") and Taggart Global, LLC, a Pennsylvania limited liability company ("Taggart Global") (Parent and Taggart China and Taggart Global are each, a "Grantor" and collectively, the "Grantors") granted a security interest in certain personal property to the Secured Party identified in paragraph 4(i) and 4(ii) of the Security Agreement ("the Trademarks and Goodwill"), including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses identified on Schedule A;

WHEREAS, the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office on June 2, 2010 at Reel 004216 Frame 0615; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in all of such Trademarks and Goodwill upon payment in full of all of the Obligations as defined in the Security Agreement.

NOW, THEREFORE, in consideration of payment in full of the Obligations, the Secured Party hereby terminates and releases all mortgages, liens, and security interests granted to the Secured Party in the following:

1. all of the Grantors' Trademarks, including but not limited to those referred to on Schedule A attached hereto;
2. all goodwill of each Grantors' business, including without limitation, such goodwill connected with the use of, and symbolized by the Trademarks, including all those trademarks identified in Schedule A hereto;
3. all licenses related to Grantors' Trademarks, including but not limited to those referred to on Schedule A attached hereto; and
4. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantors against third parties for past, present or future (i) infringement, dilution of or damage to any Trademark or (ii) injury to the goodwill associated with any Trademark, and any damages arising from past, present and future violations thereof.
