ASSIGNMENT OF US TRADEMARKS

This Assignment of US Trademarks ("**Assignment**") effective as of July 1, 2013, is entered into by and between Nu Horizons Electronics LLC, a Delaware limited liability company formerly known as Nu Horizons Electronics Corp. ("**Assignor**"), and Arrow Electronics, Inc., a New York corporation ("**Assignee**").

WHEREAS, Assignor is the owner of those certain trademark and trademark applications set forth in the attached Schedule A (the "**Trademarks**"); and

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all of Assignor's right, title, and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor and Assignee hereby agree as follows:

1. Conveyance and Acceptance. Assignor hereby assigns, transfers, and conveys to Assignee all of Assignor's right, title, and interest in and to the Trademarks along with (i) any and all extensions and renewals of the foregoing; (ii) all of the goodwill of the business connected with the use of and symbolized by the foregoing; and (iii) all rights of action pertaining to the Trademarks, including without limitation the right to sue and recover for past, present, and future infringement thereof, the right to secure registration of the Trademarks and of this Assignment, the right to initiate other proceedings before all government and administrative bodies with respect to the Trademarks, and the right to claim priority, file foreign counterparts, and make extensions and renewals with respect to any of the Trademarks.

2. Counterparts. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original (including facsimile copies), but all of which together shall constitute one and the same instrument.


3. Choice of Law. This Assignment will be governed by and construed in accordance with the laws of the State of New York, without giving effect to any choice or conflict of law provision or rule that would cause the application of the laws of any other jurisdiction.
