First Supply Group, Inc., a corporation organized and existing under Chapter 180 of the Wisconsin Statutes, does hereby certify as follows:


1. The name of the corporation is First Supply Group, Inc.

The name of the corporation shall be Prometheus Group, Inc.

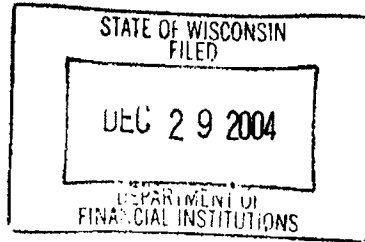
