**RELEASE OF
SECURITY INTEREST
IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is given as of this 28th day of June, 2013 by Wells Fargo Bank, National Association, successor-in-interest to Wachovia Bank, National Association (the “Agent”), to Parkdale Mills, Incorporated, a North Carolina corporation (the “Pledgor”).

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into an Amended and Restated Pledge and Security Agreement, dated as of April 30, 2009 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”), in favor of the Agent; and

WHEREAS, pursuant to the Security Agreement, the Pledgor executed and delivered a Grant of Security Interest in Patents and Trademarks (“Grant”), as recorded on May 1, 2009 with the United States Patent and Trademark Office on Reel 3980 at Frame 811, pursuant to which the Pledgor granted to the Agent, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Agent’s right, title and interest in and to the Trademarks listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Grant in the United States Patent and Trademark Office as aforesaid may be removed of record.
