## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 21, 2013, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Secured Party").

4. all products and proceeds of any of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any Trademark.


