## ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS (this “**Agreement**”) is made as of this 3rd day of July, 2013 between BMO HARRIS BANK N.A. (formerly known as Harris N.A.), in its capacity as collateral agent for itself and certain secured parties (hereinafter referred to as the “**Assignor**”) and WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent for itself and certain secured parties (hereinafter referred to as the “**Assignee**”).

### WITNESSETH

WHEREAS, reference is hereby made to that certain Pledge and Security Agreement (as amended, restated, supplemented, or otherwise modified prior to the date hereof, the “**Security Agreement**”; capitalized terms used herein without definition shall have the meaning ascribed thereto in the Security Agreement) dated as of May 10, 2010, was entered into by and among Lantheus MI Intermediate, Inc. (“**Parent**”), Lantheus Medical Imaging, Inc. (“**Borrower**”), and Lantheus MI Real Estate, LLC (“**Real Estate**” and together with Parent and Borrower, the “**Grantors**”), and Assignor;

WHEREAS, pursuant to the Loan Agreement, each Grantor granted Assignor a security interest in certain of such Grantor’s assets, including, without limitation, its trademarks and trademark applications;

WHEREAS, Borrower and Assignor entered into that certain Grant of a Security Interest – Trademarks dated as of May 10, 2010, which was recorded in the records of the United States Patent and Trademark Office at Trademark Reel 004205, Frame 0594 (hereinafter referred to as the “**Trademark Security Agreement**”);

WHEREAS, Assignor desires to assign, and Assignee desires to take by assignment, all of Assignor’s rights in, to and under the Trademark Security Agreement;

WHEREAS, Assignor and Assignee entered into that certain Agreement Regarding Agency Resignation Appointment and Acceptance (“**Assignment Agreement**”) dated as of July 3, 2013, with respect to Assignor’s assignment to Assignee of, among other things as expressly set forth therein, Assignor’s rights under the Security Agreement and the Trademark Security Agreement;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Assignee, and Assignee hereby assumes and undertakes from Assignor, without recourse and without representation or warranty, Assignor’s entire right, title and interest in, to and under the Trademark Security Agreement, including, without limitation, Assignor’s entire right, title and interest and in and to the

security interest granted by each Grantor thereunder, the Collateral (as such term is defined in the Trademark Security Agreement) and the Trademarks referred to on Schedule A.


2. This Agreement may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument.
