**ASSIGNMENT OF U.S. TRADEMARKS**

NOW, THEREFORE, for good and valuable consideration paid to Assignor pursuant to the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer unto said Assignee, its successors, assigns and legal representatives, its entire right, title and interest (in and throughout the United States of America, including its territories and dependencies, and in all foreign countries) in the Marks, together with the goodwill of the business symbolized by the Marks, that portion of Assignor's business to which the Mark pertains (which is ongoing and existing), and any causes of action for any previously occurring infringement of the Marks.


Assignor will execute further papers and will take other reasonable action if necessary and proper to vest full title in and to the Marks in Assignee, or if necessary and proper for Assignee to obtain, register, renew or enforce the Marks.
