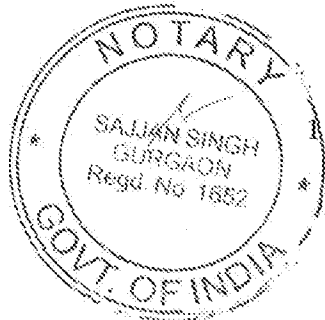
## TRADEMARK ASSIGNMENT

ASSIGNOR also agrees to sign all documents necessary to secure any and all statutory trademarks and other right based on or related to the above associated rights, and to request issuance of all such statutory trademarks and other rights to ASSIGNEE in accordance with this Assignment

2. *Further Assurances.* ASSIGNOR agrees to execute and deliver to ASSIGNEE, upon its request, such other and further instruments of assignment and such other assistance as may be reasonably requested by ASSIGNEE in the establishment, registration, preservation and enforcement of ASSIGNEE's rights to the foregoing.

3. *Choice Law.* This assignment shall be governed by and interpreted in accordance with laws of India (regardless of that or any other jurisdiction's choice of law principles).
