TRADEMARK ASSIGNMENT AGREEMENT

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers and contributes to Assignee all of Assignor's right, title and interest of whatever kind in and to the Mark, together with (1) the registration of the Mark, as shown in EXHIBIT A; (2) the goodwill of the business relating to the Products in respect upon which the Mark is used and for which it is registered, along with any services associated therewith; (3) all income, royalties and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation, damages and payments for past or future infringements, misuses and misappropriations of the Mark; and (4) all rights to sue for past, present and future infringements, misuses or misappropriations of the Mark.

Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this TRADEMARK ASSIGNMENT AGREEMENT. Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions reasonably necessary for securing, completing or vesting in Assignee full right, title and interest in the Mark.


