BEFORE ME, the undersigned authority, personally appeared William J. Bass, known to me to be a credible person over the age of 18, and deposed and stated as follows:

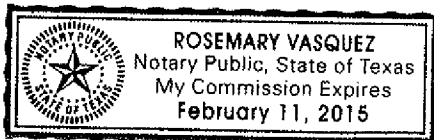

- (4) I know this information from my own knowledge and from the business records of Helen of Troy Limited.


