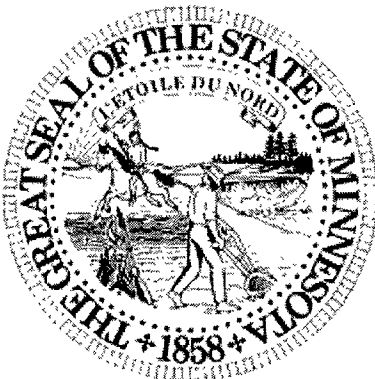

(a Minnesota nonprofit corporation)


Pursuant to the provisions of Chapter 317A Minnesota Statutes, the undersigned domestic nonprofit corporations hereby adopt the following Articles of Merger:

1. **Constituent Entities.** The names of the entities that are parties to the Merger are:
 - a. **Working Family Resource Center**, a Minnesota nonprofit corporation (“WFRC”), and
 - b. **Lifetrack Resources, Inc.**, a Minnesota nonprofit corporation (“Lifetrack”).
2. **Agreement and Plan of Merger.** The Agreement and Plan of Merger, dated July 1, 2013, is attached hereto as Exhibit A and incorporated herein by reference (the “Plan”).
3. **Surviving Entity.** Lifetrack will be the entity to survive the Merger.
4. **Necessary Approvals.** The Plan has been duly adopted and approved by the directors and sole member of WFRC and by the directors of Lifetrack pursuant to the requirements of Minnesota Statutes, Section 317A.613. Lifetrack has no members.
5. **Notice to Attorney General.** Both WFRC and Lifetrack are organizations exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 and, as such, the merger of WFRC with and into Lifetrack is exempt from the notice requirements of Minnesota Statutes, Section 317A.811.
6. **Effective Date.** The Merger shall become effective at 5:00 p.m. on the date these Articles of Merger are filed with the Minnesota Secretary of State.


