**CONFIRMATION OF SECOND LIEN INTELLECTUAL PROPERTY SECURITY**

**THIS CONFIRMATION OF SECOND LIEN INTELLECTUAL PROPERTY SECURITY** ("**Agreement**") dated as of June 27, 2013 is made by **FOUR SEASONS HOTELS LIMITED**, a corporation incorporated under the laws of the Province of Ontario (the "**Grantor**") in favour of **CITIBANK, N.A.**, as collateral agent (in such capacity, together with its successors and assigns from time to time, the "**Collateral Agent**"), with an address at Citibank N.A., (c/o Citicorp North America Inc.), 388 Greenwich Street, New York, New York, 10013.

**WHEREAS** the Grantor is party to a Second Lien Pledge and Security Agreement (Canada) dated as of June 27, 2013 (as amended, supplemented or otherwise modified or restated from time to time, the "**Second Lien Security Agreement**"), pursuant to which the Grantor has granted to the Collateral Agent a continuing security interest in and to, among other things, all Intellectual Property (as such term is defined in the Second Lien Security Agreement) of the Grantor (its "**Intellectual Property**");

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Grantor, the Grantor confirms that it has granted, and for greater certainty hereby grants, to the Collateral Agent a continuing security interest in its Intellectual Property including, without limitation, the Intellectual Property listed in Schedule A hereto, as continuing security for the payment and performance of the Obligations (as such term is defined in the Second Lien Security Agreement whether directly or incorporated by reference).


This Agreement shall be governed by and interpreted and enforced in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.

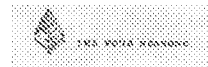

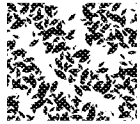
